

 - Numerous discussions with risk partners across system


ERM Program Maturity

The ERM program has matured through:

- Identifying emerging risks as they arise
- Demonstrating risk and residual risk to inform initiatives and operations
- Engaging multi-disciplinary risk partners across the University on risk assessment, risk mitigation and risk management
- Implementing the ERM program in accordance with a two-year program cycle of identifying, assessing, mitigating and monitoring risk
- Engaging with risk partners across the system to identify, document and assess mitigation strategies
- Cultivating a risk-informed culture

- 133 Mitigation strategies documented and assessed
- Demonstrated overall movement in reducing risk exposure (residual risk)

ERM Program Recognition

 Winner of Outstanding Achievement for Enterprise Risk Management Award



- Criteria:
 - Adoption of ERM by upper risk management
 - Risk appetite and tolerance are defined in ERM program
 - Stakeholders are clearly identified
 - ERM training is provided to staff
 - Organizational risks have been identified using a risk register
 - Risk owners have been assigned throughout the entire entity
 - Risk treatment plans have been established
 - Integrated performance measures, for example, early warning signs are used
 - Use of an ERM communication plan
- The ERM Team will accept the award in June 2024 at the PRIMA National Conference
- Invited to conduct a webinar for PRIMA membership on Data and ERM (Fall 2024)
